

Battle of Lanes Chennai – Terms & Conditions

A. 1. Eligibility

- A. The tournament is open to individuals above the age of 12 years organized by Timezone Entertainment Private Limited, hereinafter referred to as 'Timezone'/'Organizer'.
- B. Participants must register at Timezone Express Avenue, Chennai, Level 3 (Participating Venue).
- C. Employees of Timezone and their immediate family members are not eligible to participate.
- D. Professional Bowlers who have played at a city, state, or national level are not eligible to participate.

2. Registration

- A. Registration/Participation Fee (Entry Fee) is ₹400 per participant.
- B. The Entry Fee includes one game of bowling that will be loaded on the participant's existing Timezone Card or a new Timezone Card.
- C. Participants must provide valid ID proof (PAN/Aadhar), and complete all required fields while filling up the registration form.
- D. A Participant must carry the registered Timezone card throughout tournament for validation purposes.
- E. The contact number mentioned in the registration form shall be used for all communication through SMS/WhatsApp messages.
- F. The registration fee is non-transferable and non-refundable.

3. Tournament Format

Round 1: Dates: September 01 – 30, 2025

- A. A participant shall record their best score during the phase of Round 1.
- B. A maximum of 5 scores can be recorded out of which the highest will be taken for evaluation and progress to the next round.
- C. A participant is required to submit his/her scores to the Bowling marshal who shall be overseeing the game plays, in the perforated section of the registration form.
- D. The Bowling Marshal have the right to verify the scores mentioned in the form.
- E. The top 20 participants will qualify for further rounds.

Grand Finale: Date: October 4, 2025, | 09:00 AM

- A. The top 20 participants from Round 1 compete against each other in the Quarter Final Round.
- B. Top 8 participants qualify for Semi Final Round in which they shall compete in a group of two on 4 lanes
- C. Top scorers from each lane shall compete for the Final Round for Winner and 1st Runner up positions.

4. Score Submission

- A. Scores must be recorded immediately after the completion of the game.
- B. Only scores signed and stamped by the Bowling Marshal will be considered valid.
- C. Participants must carry the participation form for all the rounds for validation purposes.
- D. In case of a tie between two participants, qualifier will be decided based on the number of strikes recorded in the score sheet.

5. Prizes

- A. Winner: ₹10,000 + Bowling Champion Trophy.
- B. 1st Runner-Up: ₹5,000.
- C. Prizes are non-transferable and cannot be exchanged for other items.
- D. TDS 30% U/S 194B would be deducted from the Prize Money.
- E. Prize money shall be credited to the winners' account in 7 working days after receipt of documents for validation.

6. Conduct & Disqualification

- A. Participants must adhere to the rules and timelines of the tournament.
- B. Any form of cheating, misrepresentation, or misconduct will result in immediate disqualification and the decision of the Organizer shall be final.
- C. No show or delay in arrival shall be considered disqualified.
- D. Timezone reserves the right to disqualify any participant during the tournament.

7. Liability

- A. Timezone is not responsible for any injuries, accidents, or loss of personnel belongings during the tournament.
- B. By consenting to participate in the tournament, the participants waive the

Organizer from any and all liabilities that may occur during the tournament, including but not limited to 7a above, and hospitalization, compensation of any nature and by whatever name called.

8. Data & Consent

- A. By registering for the tournament, the participants provide their consent to the use of their name, image, and scores for promotional purposes.
- B. Personal data will be handled following Timezone's privacy policy.

9. Changes & Cancellation

- A. Timezone reserves the right to modify the tournament structure, schedule, or prizes at any time without giving any reason and the decision of the Organizer shall be final and binding on the participants.
 - B. In case of a force majeure event, Timezone shall provide 1 more game of bowling only and no cash refund:
 - i. For all participants, if the tournament gets cancelled in stage 1
 - ii. For qualifiers of Stage 2, if the tournament gets cancelled in stage 2
- In case of unforeseen circumstances, the tournament may be postponed or cancelled.

10. Miscellaneous

- A. Any dispute arising out of this event shall be resolved amicably, and in case of an impasse, it shall be guided by the exclusive jurisdiction of the courts in Mumbai.
- B. The terms and conditions shall be displayed on the website at www.timezonegames.com and the venue, and the Organizer reserves the right to add, alter, or modify the terms at any time, if required or necessary, without giving any intimation.
