

## Battle of Lanes Mumbai – Terms & Conditions

### 1. Eligibility

- 1a. The tournament is open to individuals above the age of 18 years organized by Timezone Entertainment Private Limited, hereinafter referred to as 'Timezone'/'Organizer'.
- 1b. Participants must register at one of the 5 participating Timezone venues (Participating Venues) located in the following malls, namely
- i. Inorbit Mall, Malad
  - ii. Phoenix Market City Mall, Kurla
  - iii. Palladium Mall, Lower Parel
  - iv. R City Mall, Ghatkopar, and
  - v. Inorbit Mall, Vashi
- 1c. Employees of Timezone and their immediate family members are not eligible to participate.
- 1d. Professional Bowlers who have played at a city, state, or national level are not eligible to participate.

### 2. Registration

- 2a. Registration/Participation Fee (Entry Fee) is ₹500 per participant, payable at the venue from where the participant wants to participate in the tournament.
- 2b. The Entry Fee includes one game of bowling that will be loaded on the participant's existing Timezone Card or a new Timezone Card.
- 2c. Participants must provide valid ID proof (PAN/Aadhar), and complete all required fields while filling up the registration form.
- 2d. A Participant must carry the registered Timezone card through out tournament for validation purposes.
- 2e. The contact number mentioned in the registration form shall be used for all communication through SMS/WhatsApp messages
- 2f. The registration fee is non- transferable and non-refundable.

### 3. Tournament Format

#### Round 1:

**Dates: July 13–27, 2025**

- A participant shall record their best score within the round 1 duration.
- A maximum of 5 scores can be recorded out of which the highest will be taken for evaluation and progress to the next round.
- Minimum points to qualify for the next round are 125 points
- A participant is required to submit his/her scores to the Bowling marshal who shall be overseeing the game plays, in the perforated section of the registration form.
- The Bowling Marshal have the right to verify the scores mentioned in the form.
- The top 20 participants above 125 points from each location are selected and moved to Round 2.
- The participants can register from any of the participating locations.

**Round 2:**

**Date: August 2, 2025 (From 09:00 am to Noon)**

- The top 20 participants from Round 1 compete against each other
- Top 10 participants qualify from Round 2 to Round 3
- Participating locations cannot be changed in Round 1 & Round 2.

**Round 3:**

**Date: August 10, 2025, (From 09:00 am to Noon)**

- The top 10 participants from each venue, totaling 50 participants, shall compete for the TOP 4 positions at **Inorbit Mall Malad.**
- There will be 2 slots for the conduct of the competition, of an hour. The organizer shall inform the participants of the slot that they need to be present.
- The slots given to the participants shall be final and cannot be exchanged with any other participant
- **The Top 4 scorers shall compete for Winner, 1<sup>st</sup> Runner up and 2<sup>nd</sup> Runner up positions.**

**4. Score Submission**

4a. **Scores must be recorded immediately after the completion of the game.**

4b. Only scores signed and stamped by the Bowling Marshal will be considered valid.

4c. Participants must carry the participation form for all the rounds for validation purposes.

4d. In case of a tie between two participants in round 1, qualifier will be decided based on the number of strikes.

**5. Prizes**

5a. Winner : ₹20,000 + Bowling Champion Trophy

5b. 1st Runner-Up: ₹10,000 + Bowling Champion Trophy

5c. 2nd Runner-Up: ₹5,000 + Bowling Champion Trophy

5d. Prizes are non-transferable and cannot be exchanged for other items.

5e. TDS @ 30% U/S 194B would be deducted from the Prize Money.

**6. Conduct & Disqualification**

6a. Participants must adhere to the rules and timelines of the tournament.

6b. Any form of cheating, misrepresentation, or misconduct will result in immediate disqualification and the decision of the Organizer shall be final.

6c. No Show for Round 2 and Round 3 as per the given slots shall be considered disqualified.

6d. Timezone reserves the right to disqualify any participant during the tournament.

**7. Liability**

7a. Timezone is not responsible for any injuries, accidents, or loss of personal belongings during the tournament.

7b. By consenting to participate in the tournament, the participants waive the Organizer from any and all liabilities that may occur during the tournament, including but not limited to 7a above, and hospitalization, compensation of any nature and by whatever name called.

## **8. Data & Consent**

8a. By registering for the tournament, the participants provide their consent to the use of their name, image, and scores for promotional purposes.

8b. Personal data will be handled following Timezone's privacy policy.

## **9. Changes & Cancellation**

9a. Timezone reserves the right to modify the tournament structure, schedule, or prizes at any time without giving any reason and the decision of the Organizer shall be final and binding on the participants.

9b. In case of a force majeure event, Timezone shall provide 1 more game of bowling only and no cash refund:

- i. For all participants, if the tournament gets cancelled in stage 1
- ii. For qualifiers of Stage 2, if the tournament gets cancelled in stage 2 and
- iii. For Finalists, if the tournament gets cancelled in Stage 3 / Finals

In case of unforeseen circumstances, the tournament may be postponed or cancelled.

## **10. Miscellaneous**

10a. Any dispute arising out of this event shall be resolved amicably, and in case of an impasse, it shall be guided by the exclusive jurisdiction of the courts in Mumbai.
